MEMORANDUM

Of cooperation in the field of basic geodetic works, cartography, real estate cadastre, geoinformatics and spatial data infrastructure

Between

The Agency for Real Estate Cadastre of the Republic of North Macedonia
and the Kosovo Cadastral Agency of the Republic of Kosovo

Article 1

With this Memorandum, the Agency for Real Estate Cadastre of the Republic of North Macedonia (herein referred to as AREC) and the Kosovo Cadastral Agency (herein referred to as KCA) of Republic of Kosovo (hereinafter referred to as: signatories of the Memorandum) establish the common interest of cooperation in the field of the basic geodetic works, cartography, real estate cadastre, geoinformatics, and spatial data infrastructure.

Article 2

The cooperation of the signatories of the Memorandum in the fields defined in Article 1 includes:

1. Exchange of information on the activities of the signatories of the Memorandum (via e-mail, mail, delegations, exchange of publications, etc.);
2. Exchange of scientific and technical information, regulations, specifications, standards and products;
3. Exchange of non-classified cartographic data;
4. Training and staff exchange;
5. Preparation and implementation of regional projects of common interest, financed through the funds of the European Union and other donor countries;
6. Harmonization of the positions and joint appearance before international professional organizations, through the representation of the common harmonized interests;
7. Joint organization of conferences, workshops and international promotion of joint cooperation programs;
8. Other activities of common interest for both signatories of the Memorandum.

Article 3

The signatories of the Memorandum shall assist one another and encourage the implementation of joint projects in the fields listed in Article 1 of this Memorandum, according to their powers as per national legislation of both Parties.

Article 4

In order to monitor the implementation of this memorandum, propose new activities and give directions for their implementation, the signatories of the Memorandum shall meet once a year, alternately in the Republic of North Macedonia and the Republic of Kosovo.

Article 5

This memorandum is signed for a period of five (5) years.

Each signature may, at any time, terminate this Memorandum, with a written letter sent to the other Party six months (6 months) prior to the termination.

The termination of the Memorandum shall not affect the completion of the activities agreed with the Memorandum and started before the date of the termination of the Memorandum, unless the contracting Parties agree otherwise.

Article 6

This Memorandum may be amended and supplemented by mutual written consent of the signatories.

Article 7

Any dispute concerning the interpretation of the implementation of this Memorandum shall be resolved by means of joint consultations and negotiations between the signatories.

Article 8

This Memorandum has been drawn up in two (2) original copies in English language, each Party receiving one duly signed copy hereof.
