1.	<p><i>In relation to the ‘Quality Control Contractor for Cadastral Reconstruction’ tender (contract no.: XK-KCA-101492-CS-QCBS), I would like to kindly request the annexes referred to in the Terms of Reference (Annex 1 - Technical Specifications for CR in 120 Cadastral Zones; Annex 1 - Technical Specifications for RCI in 120 Cadastral Zones) which were not attached to the ToR available on the akk.rks-gov.net website.</i></p> <p><i>In addition, I would like to kindly enquire about the following qualification requirement: ‘Documentation showing that the company/consortium has experience of applying international standards (ISO) for quality control, information technology and information security related to geospatial and land administration data’. Could you please clarify if you require any specific ISO standards?</i></p>	<p>The Kosovo Cadastral Agency has revised latest Technical Specifications for Cadastral Reconstruction (CR) to be undertaken in up to 115 cadastral zones across Kosovo and such change have result in changes to the Terms of Reference for Quality Control Contractor for Cadastral Reconstruction. The revised TOR for subject Quality Control Contractor for Cadastral Reconstruction are published in KCA website and available on the akk.rks-gov.net website.</p> <p>Annex 1 you are referring is for part of reconstruction of cadastral zones (another tender) to be published soon, therefore cannot be distributed yet.</p> <p>The qualification requirement should be read and understand as described in the REOI and TOR.</p>
2.	<p><i>On the website of AKK, it is published for expressions of interest as a subject and it is not announced that further information can be requested.</i></p> <p><i>My question is, is there any other information about this procedure? Is the expression of interest in the Albanian language or in any other language? The requested documentation must be submitted together with the expression of interest or at a later time.</i></p>	<p>All necessary information's for subject Quality Control Contractor for Cadastral Reconstruction are published in KCA website in English and Albanian language.</p> <p>The KCA has published the REOI looking to shortlist a number of qualified firms based on qualification requirements set in the REOI and TOR, while the shortlisting process used prior to inviting request for proposals in the procurement of Consulting Services. Therefore, during this</p>

		<p>process we expect that interested firm show as better they can they experience (past-experience, portfolio, availability of key experts etc.) in order to be considered and be part of shortlisted firms qualification. The firms should prepare and submit their documentations, while there is no standard bidding documents in this stage.</p>
