The Government of Kosovo GoK has received a Credit from the International Development Association (IDA) in the amount of 14.60 million EUR to finance the Real Estate Cadaster & Geospatial Infrastructure Project, expected to be implemented within a five years period. The proposed Project aims to assist the Government of Kosovo to increase the transparency and quality of land administration and geospatial data and services. The Kosovo Cadastral Agency (KCA) is the implementing agency for REGIP project within which a Project Implementation Units (PIU) will be established. The PIU will be staffed with a Head of PIU, Procurement Specialist, Financial Management Specialist, Public Relation and Communication, Legal Specialist, National Spatial Data Infrastructure (NSDI) specialist and other technical staff such as GIS/Cadastre expert, etc. The PIU will be responsible for day-to-day Project implementation and for providing specific technical oversight to project activities. The PIU will be responsible for all fiduciary aspects, such as procurement, financial management, monitoring and evaluation, and safeguards under the Project.

The Components of the project are Component A - Policy, Legal and Institutional Support; Component B - Cadastre Modernization; Component C - ICT and Geospatial Infrastructure and Component D - Project Management, Capacity Building, Public Outreach, and Monitoring & Evaluation.

The PIU is looking for a full time National Spatial Data Infrastructure (NSDI) specialist to assist Directorate for Geoinformation of KCA and PIU with professional advises and supervision on NSDI activities of the component C of the project. The objective of component C is to make important IT and geospatial investments in the Kosovo land and property market, and to support the implementation of KCA's IT and NSDI Strategies.

Job Description

The functions and responsibility of the KCA/PIU National Spatial Data Infrastructure (NSDI) specialist will be to assist Directorate for Geoinformation of KCA and PIU with professional advises and supervision on NSDI activities of the component C of the project. The NSDI activities are related to implementation of engagement strategy and awareness raising to maximize usage; technical training; review and update of the NSDI business model.

Specific tasks will be as follows:

- Professional advice for KCA in following establishment of NSDI according to the NSDI Strategy and the Law on NSDI in Kosovo;
- Professional support in coordinating the activities with other stakeholders for implementing strategy and the Law on NSDI;
- Analyses and supports KCA on managing the work of spatial data infrastructure at state level:
- Monitors the implementation of the NSDI Strategy and participates in the preparation of reports, as well as in drafting annual NSDI plans;
- Informs and supervises the application of relevant international standards related to the spatial data infrastructure;
- Supports the implementation of NSDI development;
- Supports in organizing the establishment of a state service for metadata for other stakeholders in accordance with the law;
- Participates in different trainings for building professional capacities;
- Prepares and participates on preparation of ToR's, participates on evaluation committees, and other activities at KCA. Also, can be appointed as Project Manager for the activities of KCA related to the NSDI implementation.
- Any other duties related to NSDI, required by the Executive Director of KCA, and Head of PIU.

Required qualifications and experience:

- Bachelor's degree in Geodesy, Geomatics, Computer Science, Information Systems or related fields. Master's degree would be an advantage;
- Minimum 3 years working experience in GIS and NSDI-related activities;
- Experience with INSPIRE directive, specifications and services
- Experience in WebGIS technologies;
- Knowledge, skills and experience with international organizations will be an added advantage;

Required competencies and abilities

- Strong commitment to equality, fairness, integrity and human rights;
- Ability to pursue high standards of work and to be organized and effective;
- Ability to work effectively with minimum supervision and careful attention to details;

National Spatial Data Infrastructure (NSDI) specialist will report to the Head of PIU and will submit monthly time-sheets to account for the actual days worked during the calendar month.
